- THE AUTHORIZED PARTY is authorized to reproduce the photographic work(s) as described in this instrument, in the product(s) and/or event(s) indicated(s) in the previous clauses.
- THE AUTHORIZED PARTY makes the commitment not to assign or transfer copyrights inherent to the object of the present term, thus remaining the CONCEDER as its sole and exclusive owner.
- THE AUTHORIZED PARTY makes the commitment to indicate, in every use, the author of the work licensed, mentioning very clearly the name of the authors and that of the Image Bank of the State of São Paulo

5. RIGHTS AND OBLIGATIONS OF THE CONCEDING ORGAN:

- THE CONCEDER declares being the owner of the copyrights and rights of property on the works, object of this License.

- The concession of the License, object of the present term, will not interfere in the assignment and transfer of copyrights, of which the CONCEDER remains the sole and exclusive owner.
- THE AUTHORIZED PARTY makes the commitment to indicate at every use the name of the author of the work.
- THE CONCEDER makes the commitment to provide free of charge, to the AUTHORIZED PARTY, during the period of one(one) year, starting at the acceptance of the present term, the material described in item 3 of the present document.
- THE AUTHORIZED PARTY is entitled to reproduce the photographic work(s) described in this instrument, in the product(s) indicated in item 4, in all its printed and electronic (Internet) forms, in all languages and/or geographical area, for a period of 1 (one) year starting at the acceptance of the present term, provided the AUTHORIZED PARTY makes a commitment not to divulge images and/or information with sexist connotations.
- THE AUTHORIZED PARTY is not permitted to assign, transfer or sub-license the reproduction of works to third parties, without the express written agreement of the CONCEDER.

6. AMOUNT AND FORM OF PAYMENT:

The present term is celebrated free of charge, at no expenses whatsoever, from none of both parties.

7. PENALTIES:

In the eventuality, no credit is mentioned on the photographs and on the assignment of the works to third parties, without the express agreement in writing from the CONCEDER, the amount of R\$ 5.000,00 (five thousand reais) will be charged per month of publication/transmission in every piece exhibited.
